INTRODUCTION

Pristine AI, Inc., also doing business as FINLYTICA Corporation ("FINLYTICA" or "we" or "us" or "our") respects the privacy of ourusers ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website, www.Finlytica.com, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site"). Personal Data

Derivative Data

This includes exchanging information with other entities for fraud protection and credit risk reduction.

Third-Party Service Providers

We may share your information with third parties that perform services for us or on our behalf, including data analysis, email delivery, hosting services, customer service, and marketing assistance.

Marketing Communications

With your consent, or with an opportunity for you to withdraw consent, we may share your information with third parties for marketing purposes, as permitted by law.

Online Postings

Cookies and Web Beacons
